

#### **Pastor's Musings**

This Sunday we celebrate All Saint's Day, or as it is known in some traditions, All Hallows' Day, the Feast of All Saints, the Feast of All Hallows, the Solemnity of All Saints, Hallowmas, and the Day of the Dead. It is a tradition that goes back centuries. There are a lot of other traditions commemorating those who have died like, Memorial Day, Veterans Day, and the list can go on. It is important for us to remember those who have gone before us. Life is tentative and all too often it seems that we may forget how precious life is. Especially when we continually hear about the thousands killed in war, the many killed in mass shootings, those who have died by suicide, or car accident.



Some of those unknown people's death may affect us as a community and/or personally. This last week with the death of Matthew Perry we see how a society grieves by the number of news articles, TV shows, and responses all around. The country as a whole mourned when significant people such as John F. Kennedy, Dr. Martin Luther King Jr., Robert Kennedy, John Lennon, and the list can go on and on died tragically.

It is important to acknowledge that we are affected by death, either from near or afar. Death lifts up our own mortality, the frailty that we all live with. There is also another part of this grieving, it is "loss." The loss of someone close to us has many losses. When my dad died, I did not lose a relationship because I did not have one with him. What I did lose was the possibility of having a relationship, as unlikely as that was. I had a friend tell me that after his dad died, he would occasionally pick up his phone to call his dad, only to realize that his dad was gone.

It is not easy to prepare for someone's death or your own. If I make out a will, I may die the next day. If I acknowledge I am losing the ability to do something or that my health is declining then it will become a reality, even though the reality was already here. One of my roles as a chaplain was to help people get to the place that they could accept the reality of what was happening.

Anne's father died a month after the two of us began our relationship. A year and a half later we had moved to Charlottesville. I invited Anne to accompany me to a presentation put on by the chaplain of the hospice. Anne assumed she was a passive bystander. It turned out she had some grieving to do and the presentation allowed her to do that. We don't always know what we need to do to get through grief, sometimes it needs help from another event or a person to help us.

It is obvious that we at St. James are in that time. Is there something that we as a community need to do to support each other? I hope and pray we can and will do that.





The 26 participants enjoyed refreshments and fellowship following the program.


Many stories were shared about the quilts in our lives.

### St. James Lutheran Church Council Meeting October 10, 2023, at 7:00 p.m.

**Call to Order:** Gene Giltner, President, called the meeting to order.

Pastor Gordon opened the meeting with a devotion. He shared the story of a man who had a grace-filled experience to see himself as others saw him and the freedom to set his life in a different direction. This man, once known as the "Dynamite King" is today best remembered as the founder of the Nobel Peace Prize – Alfred Nobel. Grace leads to a change of heart – to repentance. Repentance forces us to look at ourselves honestly and acknowledge our failings. Repentance is also a grace-filled gift because it leads us back to the grace of God.

The **Minutes** for the September 19th Council Meeting were presented. A motion was made by Paul and seconded by Ivan to approve the minutes. The motion passed.

The **Financial Report** for September was presented. A motion was made by Paul and seconded by Ivan to accept the report. The motion passed.

**Pastor's Report:** Pastor Gordon reported that he recently participated in a Boundaries Training, a three-year cycle ELCA program related to the behavior of pastors.

He reported that he continues to visit our shut-ins.

Pastor Gordon reported that he has had discussion with several people regarding a substitute organist. Organists are few and far between. A passive search will continue, as we anticipate that Hannah will continue through her years at JMU.

Pastor Gordon reported that he and Anne will be on vacation 10/14 through 10/22.

### **Committee Reports:**

- Property Committee: Paul gave a thorough report of the numerous items being addressed based on priorities established by the committee.
  - The #1 item is the roof covering the administration "schoolhouse" portion of the building. Paul will give a Temple Talk on 10/15 to present the information to the congregation.
    - Paul made a motion to call a Congregational Meeting on 10/29 for the purpose of requesting approval of up to \$8,000 to replace the roof. Ivan seconded. The motion passed.
  - Paul reported that one bid for exterior painting is \$3,300. This is being placed on hold due to the weather. A bid of \$850 has been received to paint the trim and doors in the Fellowship Hall. Two more bids are needed.
  - There are two dead trees near the pavilion that need to be removed at a cost of \$750.

- $\circ\,$  John Wright has been working of repairs to the mortar on the front of the church.
- Stewardship & Finance: No report.
- Social Ministry & Evangelism: Anne reported that invitations for the oyster dinner are going out this week to those who attended Homecoming.
- Worship, Music, & Altar: Pastor Gordon reported on the upcoming Advent Season services and activities around Christmas. Christmas day is on a Monday which adds an added challenge to scheduling services.
- Constitution and By-Laws Committee: No report.
